A built-in vibrate mode lets you detect an incoming call without ringing. This is particularly helpful if you're in a meeting, or some other situation where actual ringing would be bothersome. Weighing in at just under nine ounces, it's lightweight enough to take anywhere, and comes with its own belt clip.
